YOU MUST BE ON SITE TO SET-UP BY 10 AM ON FRIDAY TO AVOID EXPERIENCING LONG DELAYS WAITING FOR SET-UP INSTRUCTIONS.

POWER IS PROVIDED FOR VENDING SETUPS ONLY.

THERE IS A \$15.00 PER NIGHT FEE DUE AT THE TIME OF SETUP FOR ANY CAMPER OR RV'S PLANNING TO USE VENDOR ELECTRICITY.

- **SELL ONLY ITEMS NOTED ON APPLICATION. IF YOU DO NOT PAY FOR A FOOD/BEVERAGE SPOT YOU MAY NOT SELL ANY FOOD, WATER OR BEVERAGES.**
- **NO REFUNDS WILL BE MADE FOR ANY REASON, ANY CANCELLATION, REMOVAL FOR CAUSE, OR ACT OF GOD.**

- **IF YOU NEED 30AMP POWER YOU MUST BRING A GENERATOR.**
- **PLEASE CHECK WITH US RATHER THAN ASSUME THE SET UP IS WHAT YOU'LL NEED. YOU MUST BRING SUITABLE CONTAINERS TO HANDLE YOUR GREY WATER & GREASE. RUNNING WATER IS AVAILABLE AT THE SITE BUT IS NOT AVAILABLE ADJACENT TO ANY SPOT.**
